Markets Recap & September Opportunities

August's market momentum was **undeniable—record-breaking highs, Fed rate-cut hopes**, and a **tech-driven rally** dominated headlines. Yet beneath the optimism, subtle shifts in jobs, inflation, and sentiment hinted at September's real show-stoppers ahead.

August 2025: Flashback Snapshot

- **Record Highs Across U.S. Markets:**

The **S&P 500** hit an **all-time closing high** of 6,481.40 on August 27, pushing equities into optimistic territory amid growing expectations of a September rate cut. The **Nasdaq** and **Dow** followed suit with notable gains.

- **Powell Sparks Rate-Cut Optimism:**

At Jackson Hole, Fed Chair **Jerome Powell** leaned **dovish**, highlighting **easing inflation and labor risks**, which fueled speculation of a September rate cut and fueled a market rally.

- **Global Volatility and Sector Flips:**

Markets cooled in Asia **post-Nvidia's mixed earnings**, exposing sector sensitivities tied to trade and China exposure. Meanwhile, equity fund inflows cooled sharply, even as bond funds continued to attract capital.

- **Uneven Macro Backdrop:**

Despite market highs, foundational data hinted at caution: U.S. payrolls underwhelmed, revisions trimmed prior gains, and global PMI data signaled a patchy growth recovery.
